ARTICLES OF INCORPORATION OF Heartstrings Ministries Inc.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I NAME

The name of the corporation shall be: Heartstrings Ministries Inc.

ARTICLE II PRINCIPAL OFFICE
