### ARTICLES OF AMENMENT TO THE ARTICLES OF INCOMPOSE LA LAGUNA, CONDOMINIUM ASSOCIATION, INC., A NOW CORPORATION .

WHEREAS, the Board of Directors of La Laguna, Condominium Association, INC. have determined that it would beneficial if the corporation's Articles of Incorporation were amended to better comply with Florida law regarding condominiums.

BE IT DULY RESOVLED that the Articles of Incorporation of the above mentioned corporation are hereby amended by revising Article IX section C. so that it shall now read as follows:

C. The First Board shall serve until the "Initial Election Meeting ", as hereinafter described, which shall be held on a date which is at least (90) days after the sending of notice by Developer to the Association that Developer voluntarily waives its right to continue to designate the members of the First Board, whereupon the First Board shall resign and be succeeded by the "Initial Elected Board" (as hereinafter defined).

This amendment was adopted unanimously by the Board of Directors at a meeting at which notice was waived that was held on March 14, 2005. There are no members.

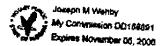
