
To whom it may concern:

On April 28, 2003 we filed our Uniform Business Report for 2003. When we attempted to download our Annual Report for 2004, the sunbiz website listed our corporation as inactive. When we called to inquire about this, we were told that a letter of rejection was sent to us on May 16, 2003 because the FEI number was not provided on the form. We never received this letter. We were advised to file a reinstatement form for 2003 and 2004 (enclosed with this letter). Also, when we paid our fee for 2003, we overpaid. We paid the fee for a "for profit" corporation instead of the fee for a "not-for-profit" corporation. The representative we spoke with said that due to our situation, the reinstatement fee would be waived. Based upon our records, this should be our status:
