We, the undersigned, do hereby certify that we have associated ourselves together for the purpose of becoming a not for profit corporation under the laws of the State of Florida, providing for the formation, rights, privileges, and communities of a not for profit corporation. We further declare that the following Articles shall be the charter and authority for the conduct of business of said corporation.

**ARTICLE I**

**NAME**

The name of this Corporation shall be  
**CHRISTIAN COMMUNITY MISSIONS INC.**

**ARTICLE II**

**PRINCIPAL OFFICE**

The principal place of business shall be in the City of Auburndale, County of Polk, State of Florida, with the mailing address of 1052 Hwy 92 W. Auburndale Florida 33823, but it shall have the power and authority to establish branch offices as such place or places as may be designated by the Board of Directors.

**ARTICLE III**

**PURPOSE**

The general nature of the business or businesses to be transacted in which the corporation is authorized to transact, in addition to those

authorized by the laws of the State of Florida and the powers of said corporation, shall be as follows:

1. To establish a local worship and missionary church. Said Church would be called "The Christian Community Church".
2. To help the homeless and needy families in the local community of the Church.
3. In general, to carry on any and all incidental missionary business, to have and exercise all the powers conferred by the laws of the State of Florida concerning church and state, and to do any and all things here-in-before set forth to the same extent as a religious institution might or could do. Nothing herein contained shall be deemed or construed as authorizing or permitting, or purporting to authorize or permit the corporation to carry on any business, exercise any power, or do any act which corporation may not, under the laws of the State of Florida, lawfully carryon, exercise or do.

## ARTICLE IV

### MANNER OF ELECTION

All corporate powers shall be exercised by or under the authority of, and the business and affairs of this corporation shall be managed under the direction of the Missionary Board of Directors of this Corporation. The Directors shall be appointed through a volunteered Missionary Church committee at a church business meeting conducted by the Pastor of the Christian Community Church. This article may be amended from time to time in the by-laws of the corporation by a majority vote of the church members at a church business meeting.

## ARTICLE V

### DIRECTORS/OFFICERS
