

ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF BONITA SPRINGS NEWCOMERS CLUB, INC. (#H920002378055)

Article III

The foregoing amendment shall be effectively immediately and was adopted by unanimous action of the board of directors of this Florida not-for-profit corporation, for which no shareholder action is required.
