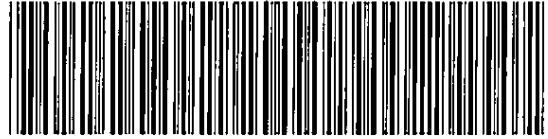

**ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION
OF
BONITA SPRINGS NEWCOMERS CLUB, INC.
(#H020002378055)**

Pursuant to the provisions of Section 607.1006, Florida Statutes, this Florida not-for-profit corporation revokes and deletes Article III of its Articles of Incorporation and, in lieu thereof, inserts the following:

Article III

The Corporation is organized exclusively for charitable purposes within the meaning of 501(c)(7) of the Internal Revenue Code of 1986, as amended, or the corresponding provision of any future United States Internal Revenue Law (the "Code") and is not formed for pecuniary profit or financial gain. The Corporation is authorized to perform any lawful act or activity for which corporations not-for-profit may be formed under the Florida Not For Profit Corporation Act. Notwithstanding any other provisions of these Articles to the contrary, the Corporation shall not have or exercise any power which would cause it not to qualify as a tax-exempt organization under section 501(c)(7) of the Code; nor shall the Corporation engage directly or indirectly in any activity which would cause the loss of such qualification.

The foregoing amendment shall be effectively immediately and was adopted by unanimous action of the board of directors of this Florida not-for-profit corporation, for which no shareholder action is required.
