# ARTICLES OF INCORPORATION OF

#### ONE:

The name of the corporation is Richard G. Curl Ministries, Inc. The principal place of business and mailing address of the corporation is 8586 Russell Avenue, Pensacola, Florida. The corporation is organized pursuant to the 501 © (3), Nonprofit Corporation Code.

# TWO:

This religious corporation is a person authorized to transact business, no one may have its name or same name, it can sue, borrow, file bankruptcy and more. This corporation is a nonprofit religious benefit corporation and is not organized for the private gain of any person. The corporation is organized under GOD in which we trust. In accordance to the Amendment of the United States Constitution and GOD Divine Status (1 Corinthians 12:28). This Religious Benefit Corporation is part of the Church, which is the body of our Lord and Savior Jesus Christ to promote religious activities. This corporation is tax-exempt and receive tax-deductible contribution as outline in IRS Publication 557 and Application 1023. This corporation is not required to file annually tax returns for church or religious related business. Any such asset not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is located, exclusive for such purposes or to such organization or organizations, as said Court shall determine which are organized and operated exclusively for such purposes.

The Directors are elected in accordance with the Bylaws. A director must be 18 years of age. The number of Directors shall be three (3).
