As per our phone call I am sending back this annual report which I sent to you in August, along with our check. I have no idea why this letter came back to me dated Sept. 29 because I was attentive on the final date due.

If there was a mailing error or I sent it to the wrong Dept' that could be the reason. You have the check and it has already gone through my bank.

Our Pantry is Non-Profit with no one receiving salaries for any work done. Each package of food we give to the Elderly on fixed incomes, Homeless, and those below the poverty level. Last year we helped over 7000 families, and every cent we receive goes into that purpose.

As you can imagine our budget is very tight depending on donations, and any Grants we can muster up. An additional cost of \$175.00 means that we can't give out about 75 to 80 bags of food. You can see that I have my costs down to the bare minimum with all of my donations.

I hope we can resolve this matter because some of my grant requests require that we remain a corporation..
