I the undersigned incorporate, hereby make, aknowledge and file these Articles of Incorporation for the purpose of forming a non-profit corporation under the laws of the State of Florida, pursuant to Florida Statutes 617.

ARTICLE I NAME

ARTICLE II NATURE OF BUSINESS

The general pupose for which this Corporation is organized is to transact any or all lawful business for which non-profit corporations may be incorporated undet Chapter 617 Florida Statutes. 
