## ARTICLES OF INCORPORATION

OF

### **CURSILLOS OF CHRISTIANITY, INC. (A Florida Not-For-Profit Corporation)**

Pursuant to Chapter 617 of the Florida Statutes, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a not-for-profit corporation.

#### **ARTICLE I - NAME**

The name of the corporation is **Cursillos of Christianity, Inc.** (hereinafter called the "Corporation").

#### **ARTICLE II - INITIAL PRINCIPAL OFFICE**

The street address of the initial principal office and mailing address of the Corporation is 16250 SW 112<sup>th</sup> Avenue, P.O. Box 652307, Miami, Florida 33265-2307

#### **ARTICLE III - PURPOSE**

The Corporation is a not-for-profit corporation, organized and shall be operated exclusively for religious and charitable purposes, within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended (the "Code"), and not for pecuniary profit

#### **ARTICLE IV - INITIAL REGISTERED AGENT**

The street address of the initial registered office of the Corporation is 1311 West 32<sup>nd</sup> Street, Hialeah, Florida 33012, and the name of the Corporation's initial registered agent at that address is Efen Leal.

#### **ARTICLE V - BOARD OF DIRECTORS**

The number of members of the Board of Directors shall initially be three (3). The number of directors may be increased or decreased from time to time in accordance with the Bylaws of the Corporation, but shall never be less than three (3). The manner of election of

**ARTICLE VI - DISSOLUTION**

Upon the dissolution or winding up of this Corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of the Corporation, shall be distributed to a not-for-profit fund, foundation, or corporation which is organized and operated exclusively for charitable purposes and which has established its tax exempt status under Section 501(c)(3) of the Code


**ARTICLE VII - LIMITATIONS**

No part of the net earnings of the Corporation shall insure to the benefit of, or be distributable to, its officers or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of any of its purposes. Notwithstanding any other provision of these Articles, the Corporation shall not carry on any activities not permitted to be carried on by a corporation exempt from federal income tax under Section 501(c)(3) of the Code.

**ARTICLE VIII - INCORPORATOR**


