ARTICLES OF INCORPORATION

OF

Pursuant to Chapter 617 of the Florida Statutes, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of incorporation for the purpose of organizing a not-for-profit corporation.

ARTICLE I - NAME

The name of the corporation is Cursillos of Christianity, Inc. (hereinafter called the "Corporation").

ARTICLE II - INITIAL PRINCIPAL OFFICE

ARTICLE III - PURPOSE

The Corporation is a not-for-profit corporation, organized and shall be operated exclusively for religious and charitable purposes, within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended (the "Code"), and not for pecuniary profit

ARTICLE IV - INITIAL REGISTERED AGENT

Upon the dissolution or winding up of this Corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of the Corporation, shall be distributed to a not-for-profit fund, foundation, or corporation which is organized and operated exclusively for charitable purposes and which has established its tax exempt status under Section 501(c)(3) of the Code

ARTICLE VII - LIMITATIONS

No part of the net earnings of the Corporation shall insure to the benefit of, or be distributable to, its officers or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of any of it purposes Notwithstanding any other provision of these Articles, the Corporation shall not carry on any activities not permitted to be carried on by a corporation exempt from federal income tax under Section 501(c)(3) of the Code.
