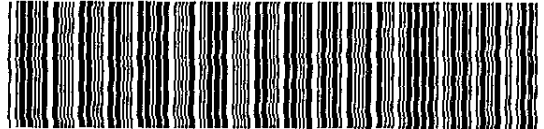

Articles of Amendment to Articles of Incorporation of:  
Sarasota House Of Prayer, Inc.

Amend Article 3 to read: Said corporation is organized exclusively for charitable, religious and educational purposes, including for such purposes, the making of distributions to organizations under section 501 (c)(3).

Add article 8: No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, directors, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of sec 501 (c)(3) purposes. No substantial part of the activity of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not intervene in (including the publishing of statements) any political campaign on behalf of, or in opposition to any candidate for public office.

Notwithstanding any other provision of the Articles, the corporations not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code) or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code (or corresponding section of any further Federal tax code.)

Add Article 9: Upon dissolution of this corporation assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the international Revenue Code, or corresponding section of any further Federal tax code, or shall be distributed to the Federal government, or to state or local government, for a public purpose.
