ARTICLES OF INCORPORATION

OF

GATEWOOD FOUNDATION, INC.
(A Corporation Not-for-Profit)

The undersigned natural person of legal age, acting as incorporator for the purpose of creating a corporation not-for-profit under the laws of the State of Florida, as provided in Chapter 617, Florida Statutes, does hereby adopt the following Articles of Incorporation:

ARTICLE I.

NAME

The name of the corporation shall be:

GATEWOOD FOUNDATION, INC.

ARTICLE II.

# PRINCIPAL OFFICE

The street address and the mailing address of the principal office of this corporation is:

4300 West Cypress Street, Suite 980 Tampa, Florida 33607

ARTICLE III.

# DURATION

The corporation shall have perpetual existence.

# ARTICLE IV.

# PURPOSES

This corporation is organized exclusively for charitable, religious, education, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law).

# ARTICLE V.

# POWERS AND RESTRICTIONS

This corporation shall have all powers granted by law to notfor-profit corporations subject to the following limitations and restrictions:

- No part of the net earnings of the corporation shall (a) inure to the benefit of, or be distributable to any members, trustees, directors, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article IV hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (i) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law) or (ii) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1986, or the corresponding provision of any subsequent federal tax laws.
- (b) No member, trustee, director, officer, or private individual, shall be entitled to share in the distribution of any corporate assets upon dissolution of the corporation. Upon the dissolution of the corporation, the Board of Directors shall, after paying or making provision for the payment of all of the liabilities of the corporation, dispose of all of the assets of the corporation exclusively for the purposes of the corporation in such

manner, or to such organization or organizations organized and operated exclusively for charitable, educational, religious, or scientific organizations under Section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law), as the Board of Directors shall determine. Any such assets not so disposed of shall be disposed of by the court of competent jurisdiction, as provided by law, of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.

- (c) The corporation shall distribute its income for each taxable year at such time and in such manner as not to become subject to the tax on undistributed income imposed by Section 4942 of the Internal Revenue Code of 1986, or corresponding provisions of any subsequent federal tax laws.
- (d) The corporation shall not engage in any act of self-dealing as defined in Section 4941(d) of the Internal Revenue Code of 1986, or corresponding provisions of any subsequent federal tax laws.
- (e) The corporation shall not retain any excess business holdings as defined in Section 4943(c) of the Internal Revenue Code of 1986, or corresponding provisions of any subsequent federal tax laws.
- (f) The corporation shall not make any investments in such manner as to subject it to tax under Section 4944 of the Internal Revenue Code of 1986, or corresponding provisions of any subsequent federal tax laws.
- (g) The corporation shall not make any taxable expenditures as defined in Section 4945(d) of the Internal Revenue Code of 1986, or corresponding provisions of any subsequent federal tax laws.

# ARTICLE VI.

# MEMBERSHIP

This corporation shall be organized on a nonstock basis and shall not issue shares of stock.

Initially, there shall be only one member of this corporation. Such member shall elect the Directors of this corporation and shall have the power to remove Directors and to amend these Articles of

Incorporation. The initial member shall be Roger B. Gatewood. Such membership shall be fully transferable by the member, provided that such transfer shall not disqualify this corporation from being (i) exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law) or (ii) able to receive contributions which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1986, or the corresponding provision of any subsequent federal tax laws.

Additional members of this corporation may be elected at any time by the member, or by a majority of the members if there are more than one member, in the manner which shall be provided in the Bylaws.

This corporation shall not is sue member certificates.

### ARTICLE VII.

# BOARD OF DIRECTORS

Control of the affairs of the corporation shall initially be vested in the Board of Directors consisting of not less than three (3) Directors, who shall be elected on an annual basis by the member (or majority of members if there is more than one member) of the corporation in the manner which shall be provided in the Bylaws, and the term of office of any Director may be for a period of more than one (1) year as provided in the Bylaws. The Directors shall have the sole voting power and control of the corporation, subject to the right of the member (or majority of members if there is more than one member) of the corporation to elect and remove the Directors and to amend the Articles of Incorporation.

The number of Directors may be, as provided in the Bylaws, increased or decreased, but shall never be less than three (3) Directors. Vacancies on the Board of Directors shall be filled by the member (or majority of members if there is more than one member) of the corporation by electing new Directors as provided in the Bylaws. The Board of Directors may be organized into one (1) or more separate categories of Directors as provided in the Bylaws. # BYLAWS

The Board of Directors shall make, and shall have the power to amend or repeal, the Bylaws of the corporation.
