ARTICLES OF INCORPORATION OF

The American Troubadour Project, Inc.

ARTICLE I. - NAME

The name of this corporation is The American Troubadour Project, Inc.

ARTICLE 2. - PRINCIPAL OFFICE: MAILING ADDRESS

The principal office of the corporation is initially 1655 Hillview St., Sarasota, FL 34239 and the mailing address of the corporation is initially 1655 Hillview St., Sarasota, FL 34239. The corporation may change its principal office and/or mailing address from time to time as permitted by law.

ARTICLE 3. - PURPOSE

This corporation is organized for the purpose of forming a not for profit corporation under the Florida Not for Profit Corporation Act to provide and maintain and conduct activities and programs related to the not for profit purposes of the corporation; and to acquire by gift, legacy, bequest, purchase, or lease; hold and manage; and/or mortgage, sell, convey, or otherwise dispose of real estate and personal property in any lawful manner that may seem proper and best to provide and maintain such; and any related religious, charitable, scientific, literary and/or educational purposes.

ARTICLE 4. - MEMBERS

The corporation shall have members. The number of members, members' qualifications, and other matters pertaining to members shall be as provided in the bylaws.

ARTICLE 5. - LIQUIDATION AND DISSOLUTION

This corporation will not have or issue shares of stock. No dividends will be paid, and no part of the income of this corporation will be distributed to its members, directors or officers. However, the corporation may pay compensation in a reasonable amount to members, officers or directors for services rendered. The property of this corporation is irrevocably dedicated to not for profit purposes and no part of the net carnings or assets of this Corporation shall inure to the benefit of a director, officer, or member of the Corporation or any private individual. No substantial part of the activities of this corporation shall consist of the carrying on of propaganda or otherwise altempting to influence legislation, nor shall this corporation participate in, or intervene in (including the publishing or distributing of statements), any political campaign on behalf of (or in opposition to) any candidate for public office. The purposes for which the corporation is organized are exclusively religious, charitable, scientific, literary and/or educational within the meaning of section 501(c)(3) of the Internal Revenue Code or the corresponding provision of any future United States Internal Revenue law, Notwithstanding any other provisions of these Articles, the corporation shall not carry on any other activities not permitted to be carried on (1) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code (or the corresponding provisions of any future United States tax code) or (2) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code (or the corresponding provision of any future United States tax code). Upon the winding up and dissolution of this corporation, after paying or adequately providing for debts and obligations of the corporation, the remaining assets shall be distributed to any organization that is organized and operated for similar purposes and is a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code (or the corresponding section of any future United States tax code).
