



**AMENDMENT TO THE  
ARTICLES OF INCORPORATION OF  
WHISPERING WOODS OF CORAL SPRINGS HOMEOWNERS ASSOCIATION, INC.**

The original Declaration of Covenants and Restrictions is recorded in Official Records Book 11628 at Page 226 of the Public Records of Broward County, Florida.

As used herein, words underlined are added and words ~~hyphenated~~ through are deleted.

**Article VII(1) of the aforesaid Declaration shall be amended to read as follows:**

The property, business and affairs of the ASSOCIATION shall be managed by a BOARD which shall consist of not less than three (3) directors, and which shall always be an odd number. The BYLAWS may provide for a method of determining the number of directors from time to time. In the absence of a determination as to the number of directors, the BOARD shall consist of three (3) directors. Directors are not required to be members of the ASSOCIATION, or the spouse of a member.
