
To whom it may concern;

I was the President of the Kissimmee/ St. Cloud Jaycees during 1999. Sometime late in June or early July I received a "Second Notice" for our "NonProfit Corporation Annual Report". There was some confusion when I took over the presidency and the first one was probably misplaced. I had the Treasurer issue a check for the filing fee and sent that in on 7/22/99. Since that time I have had the key to the Post Office Box and have not seen anything from your office. As an accountant, I go "on-line" from time to time to check on our different clients status. Recently I checked the Jaycees account and noticed that it has been dissolved. When I called your office in mid December I was told that the report was not completed correctly and that was the reason for the dissolution. I'm not sure why I only completed my information but am troubled as to why no one has attempted to contact us about this. When I signed the report I put my office phone number just in case there was any questions but apparently it was not used. The person from your office said that they mailed out a notice but no one is ever called? Why would the "Daytime Phone #" be put on the form then? I have attached a copy of the report that was filed in July, 1999 and a "revised" one that has the required number of directors on it. Hopefully this is all you need to "reinstate" our corporate status.

Currently the new board will be sworn in on January 8, 2000 and you will find a completed "Non-Profit Corporation Annual Report" enclosed with this letter.
