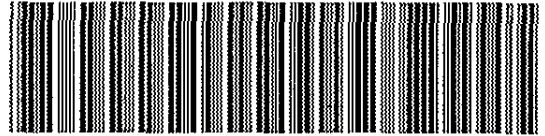

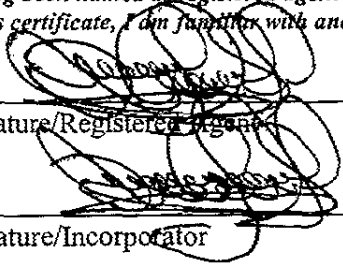

B - Is to help people in many countries as possible who are in poor or lower financial conditions.

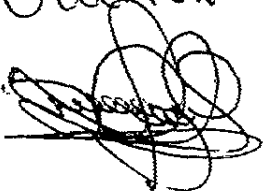
C - Is to provide enough help, support and assistance to children and young people around the world in order for them to find the opportunity or chance to achieve a better standard of living and education.
