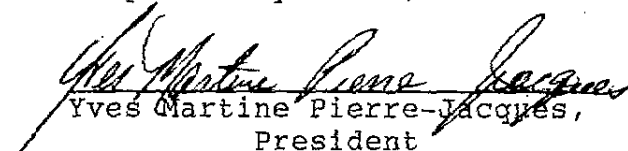

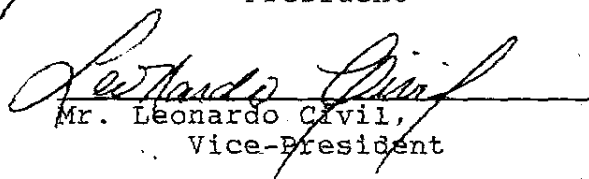

NOTWITHSTANDING ANY OTHER PROVISION OF THE BYLAWS, HUMANITY COMMUNITY SERVICE, INC. SHALL NOT CARRY ON ANY OTHER ACTIVITIES NOT PERMITTED TO BE CARRIED ON UNDER DIRECTIVES APPEARING UNDER SECTION 501 (C) (3) OF THE INTERNAL REVENUE CODE OR UNDER SECTION 170 (C) (2) OF THE INTERNAL REVENUE CODE, OR CORRESPONDING SECTION OF ANY FUTURE FEDERAL TAX CODE.
