ARTICLE ONE - NAME

ARTICLE FIVE

OFFICES AND TRUSTEES

The affairs of the Corporation are to be managed by a Board of Trustees. Each trustee shall be appointed to a committee that shall have its own specific function as to education and/or social activities. The Directors shall appoint the preliminary Trustees for the initial two (2) years. At the end of the first two (2) years, trustees will be elected into specific positions. These elections will be conducted according to the Constitution, which must be approved by the majority voting members.

ARTICLE SIX

MEMBERS

General membership shall remain open to all Christians; regardless of color, creed, race, language or nationality. Participation and cultural unity shall be encouraged with activities that will promote this.

VOTING

Voting shall be determined by the ByLaws.

ARTICLE SEVEN

BYLAWS

The Bylaws of the Corporation are to be made, altered or rescinded by the Directors of the Corporation in accordance with Florida Law.

ARTICLE EIGHT

AMENDMENTS TO ARTICLES

These Articles of Incorporation may be amended by the act of the Members of the Corporation. Such amendments may be proposed and adopted in the manner provided in the Bylaws of the Corporation.

ARTICLE NINE

REGISTERED OFFICE AND AGENT

The initial registered office of the Corporation shall be located at 1126 West Lantana Road, Lantana, FL 33462 and the initial registered agent of this corporation at such office shall be REV. JACQUES GRACIA SIMON. Upon accepting this designation agrees to comply with the provisions of Section 48.091, Florida Statutes as Amended from time to time, with respect to keeping an office open for service of process.
