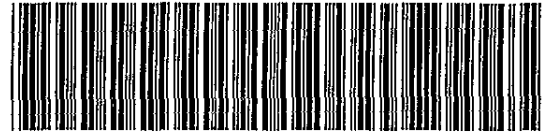

**AMENDED ARTICLES OF INCORPORATION
OF
EGLISE BAPTISTE PAR LA FOI EN CHRIST, INC.**

ARTICLE III – PURPOSES

The specific purpose of the corporation is to establish and maintain a regular church along with public worship and to help the most needy families to improve their lives without discrimination through educational and charitable services. To that end, the corporation will adopt and establish By-Laws and make all rules and regulations deemed necessary and expedient for the management of its affairs in accordance with the law and not inconsistent with these Articles of Incorporation.

To acquire, buy, hold, own, sell, exchange, convey, lease, or otherwise dispose of goods, chattels, effects and merchandise;

To mortgage, lease, hypothecate, convey, exchange, and dispose of lands and chattels to acquire by gifts, annuity, bequest, or otherwise, property, both real and personal or otherwise, and to do anything and everything pertinent to the above.

ARTICLE IV – BOARD OF DIRECTORS

The affairs of the corporation shall be managed by a President, a Vice President, a Secretary, and a Treasurer. Said directors shall be elected or appointed at the annual meeting of the corporation by a majority vote every two years.

These shall be:

Abner Fonrose.....	Treasurer

ARTICLE X – LIMITATION OF CORPORATE POWERS

No part of the net earning of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay any reasonable compensation for services rendered and to make payments and distribution in furtherance of the purposes set forth in the By-Laws. No substantial part of the activities of the corporation shall be

the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercises any powers that are not in furtherance of the purposes of this corporation.

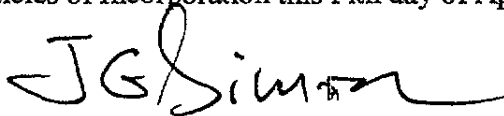
ARTICLE XII – ASSETS DISTRIBUTION IN CASE OF DISSOLUTION

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (C) (3) of the Internal Revenue Code, or the corresponding section of any future federal code, or shall be distributed to the federal government, or to the State of Florida, or City of Lantana, for a public purpose. Any such assets not so disposed of shall be disposed by a Court competent Jurisdiction of the County of Palm Beach in which the principal office of the corporation Is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
