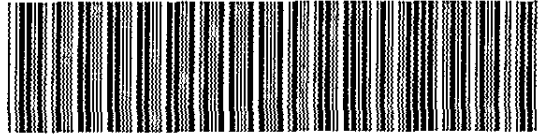

**ARTICLE III PURPOSE(S)**


