

#### ARTICLES OF INCORPORATION

OF Delray Beach Unitee Haitian Church of The Nazarene, Inc. 03 JAN -6 PM 3: 18

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, citizens of the United States, and residents of the State of Florida, being natural persons of the age of twenty one (21) years or more, for the purpose of forming a Corporation under ("The General-Not-For-Profit Corporation Act" - if above state has such an act) do hereby adopt the following Articles of Incorporation.

## ARTICLE I

The name of the Corporation is: Delray Beach Unitee Haitian Church of The Nazarene, Inc., and the address of its initial Principal and Registered Office in the State of Florida is 301 S W 12 Ave., Bldg. 12, Old Calveur, Delray Beach, FL.33445, and the name of its initial Registered Agent at such address is Rev. Saint Jäus Gay

## ARTICLE II

The duration of the Corporation is perpetual.

#### ARTICLE III

The terms of admission to membership in this Corporation shall consist of membership in good standing in the ecclesiastical body known as Christ Church of the Nazarene, Inc., and each member in good standing in such ecclesiastical body shall by virtue thereof be a member of this Corporation.

(f) Manual Church of The Nazarene (Paragraph 102.4 [4]) "Upon dissolution, the assets of the corporatio-shall be distributed to the District Advisory Board", known as the District Advisory Board of The Southers Florida District Church of The Nazarene, Inc., incorporated in the State of Florida in 1973.

#### ARTICLE VI

- (a) The Church Board, (Board of Directors), shall consist of not less than three (3) members of the Corporation duly elected by the members of the Corporation, and shall constitute the said Church Board is accordance with the MANUAL of the Church of the Nazarene, (Paragraph 113.9).
- (b) The officers of the Church Board and of the Corporation shall consist of the Pastor of the Delray Beach United Haiian Church of The Nazarene, Inc. who shall be ex-officio Chairman of the Church Board, a Secretary and a Treasurer, both of whom shall be elected by the Church Board as provided for in the MANUAL of the Church of the Nazarene, (Paragraphs 129.19 & 129.19)
- (c) The first Church Board of this Corporation shall manage the affairs of the Corporation from the data of incorporation until the first day of the previous month in which the District Assembly is held, as provided for in the MANUAL of the Church of the Nazarene, shall consist of the following named persons, to-wit:

# ARTICLE V

This corporation is formed for the following purposes:

- (a) To spread the Gospel of Jesus Christ, promote holiness and the worship of God among its members and attendants, and practice the Christian virtues inculcated in the Holy Scriptures, and in aid thereof to acquire, own and hold by purchase, lease, gift, legacy, bequest, devise or otherwise, both real and personal property of every kind and nature, and dispose of same in any and every lawful way, and use the proceeds thereof for the purposes hereinbefore stated, or reinvest in other property, and to borrow money if need be, and hypothecate its securities, issue bonds, execute promissory notes, mortgages and all manner of conveyances and the property of this Corporation shall at all times be held, arranged and disposed of in accordance will the MANUAL of the Church of the Nazarene, (Paragraph 102).
- (b) To employ and discharge ordained ministers of the Gospel, and others, to conduct and carry on divinservices at the place of worship of the members of the Corporation, and elsewhere, and to collect and disburany and all necessary funds for the maintenance of said Corporation and the aforesaid ecclesiastical bodknown as Delray Beach Unitee Haitian Church of The Nazarene, Inc., and the accomplishment of it
  purposes, and further to comply with and conform to the principles and usages set forth in the MANUAl
  of the Church of the Nazarene.
- (c) To do all and everything necessary, suitable and proper for the accomplishment of the purposes or the attainment of any one or more of the purposes herein enumerated, or which shall at anytime appeal conducive or expedient for the promotion of its welfare, and the accomplishment of the purposes hereinnumerated.
- (d) To conduct, accomplish and carry on its objectives, functions and purposes or any part thereof, within or without the State of Florida.
- (e) The specific purposes hereinbefore enumerated shall not be held to limit or restrict in any manner the powers of this Corporation, but in general the Corporation shall have the power to do all things necessary

#### ARTICLE VII

The By-laws for the guidance and control of this Corporation shall be the MANUAL of the ecclesiastical body of the Church of the Nazarene, and said MANUAL is hereby adopted by the incorporation hereof as the By-laws of this Corporation.
