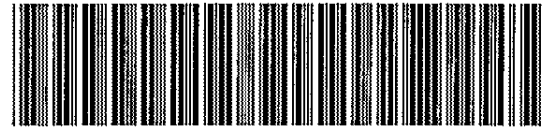

In compliance with the requirements of Chapter 617 (Not for Profit), Florida Statutes, the undersigned, being natural persons, do hereby act as an incorporators in adopting and filing the following Articles of Incorporation for the purpose of organizing a not for profit business corporation under the Florida Business Corporation Act.

**ARTICLE I  
NAME**

The name of the NOT FOR PROFIT CORPORATION ("corporation") is: NORTH FLORIDA PAGEANTS, INC.

**ARTICLE II  
PRINCIPAL OFFICE**

The address of the principal office of the corporation is 18492 105<sup>th</sup> Road, McAlpin, Florida 32062

**ARTICLE III  
PURPOSE**

The purpose of this corporation is to organize, promote, and conduct a pageant or pageants and for any lawful purpose not for pecuniary profit, such as but not limited to charitable, benevolent, educational, historical, civic, patriotic, social, literary, cultural and any and all other activities associated with the creation, promotion and production of a pageant or pageants which shall be designed to promote good moral character and educational excellence.

**ARTICLE IV  
INITIAL STREET ADDRESS AND AGENT**

The initial street address of the corporation's registered office is 18492 105<sup>th</sup> Road, McAlpin, Florida 32062. The initial registered agent for the corporation at that address is MICHELLE HAAS MCCOLLUM.

**ARTICLE V  
MANNER OF ELECTION**

The incorporators shall appoint the initial Board of Directors who shall serve until the first annual meeting in January of 2003. The Board will meet annually on or about January 1 of each year to elect or reelect directors. Minutes of said meetings will be filed in the secretary's books and

shall become a part of the corporate records. As required by law, the secretary will notify the State of any changes in the Board membership as a part of her annual report.
