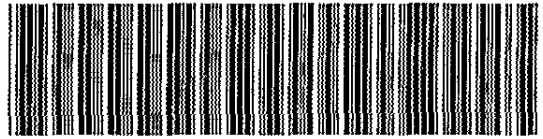

**ONE:**

The name of the corporation is DEBORAH JACKSON MINISTRIES, INC. The principal place of business and mailing address of the corporation is 5701 Tonawanda Drive, Pensacola, Florida 32506. The corporation is organized pursuant to the **Florida**, Nonprofit Corporation Code.

**TWO:**

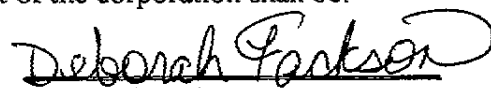
This **religious corporation** is a person authorized to transact business, no one may have it's name or same name, it can sue, borrow, file bankruptcy and more. This corporation is a nonprofit religious benefit corporation and is not organized for the private gain of any person. The corporation is organized under GOD in which we trust. In accordance to the 1<sup>st</sup> Amendment of the United States Constitution and GOD Divine Status (1 Corinthians 12:28). This Religious Benefit Corporation is part of the Church, which is the body of our Lord and Savior Jesus Christ to promote religious activities. This corporation is tax-exempt and can receive tax-deductible contribution as outline in IRS Publication 557 and Application 1023. **SIX:**

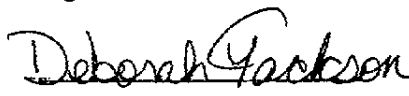
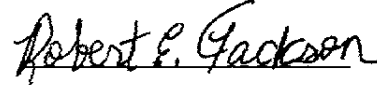
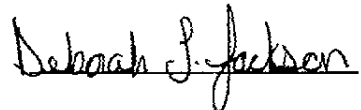

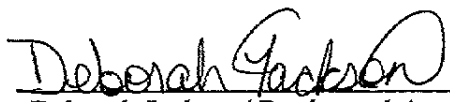
**EIGHT:**
