The undersigned, acting as incorporators of a corporation pursuant to Chapter 617/1Fforida - 6 P/ 3: 10 Statutes, adopt the following articles of incorporation for such corporation.

IALLAHASSEE FLORINA

ARTICLE I NAME

The name of the corporation is Highlands County Coalition for the Homeless, Inc.

ARTICLE II PRINCIPAL OFFICE

The principal place of business and the mailing address of the corporation is 501 S. Commerce Ave., Sebring, FL. 33870.

ARTICLE III PURPOSE

This corporation is organized to work toward the improvement of the plight of the homeless and its purposes are exclusively charitable and educational within the meaning of Section 501(c) (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law; consisting of the following:

- 1. To coordinate existing shelter and support programs, evaluate unmet needs and explore possible resources to meet identified needs.
- 2. To serve as collaborative agency for grant applications.
- 3. To educate the community and its leaders about homelessness.
