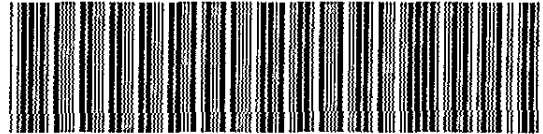

The undersigned, acting as incorporators of a corporation pursuant to Chapter 617, Florida Statutes, adopts) the following Articles of Incorporation.

ARTICLE 1- NAME

The name of the corporation shall be

RESTORATION COMMUNITY YOUTH DEVELOPMENT CENTER, INC.

ARTICLE 11 - Principal place of business and mailing address

The principal place of business of this corporation shall be 1430 NW 47 Ave, Coconut Creek Fl 33063 and the mailing address of this corporation shall be 1430 NW 47 Ave Coconut Creek Fl.33063.

ARTICLE 111 – Purpose(s)

The specific purpose(s) for which the corporation is organized is (are):

- 1) To provide a place where trained and experienced persons may help to educate, instruct and mentor young people.
- 2) To create a center for learning and personal development for the youth and other age groups.
- 3) To provide specific instructions and training on personal issues that affect the youth:
1) personal health 2) personal hygiene 3) family and peer relationship concerns 4) community values e.g. honesty and techniques on conflict resolutions
- 4) To provide a place to help the youth deal with peer pressure concerns: a) drug abuse b) alcohol abuse c) teen pregnancies d).
- 5) To provide an environment for cultural and cross cultural expressions for the youth and other age groups.
- 6) To organize and operate all faith-based functions and activities including, but not limited to, regular meetings, that will enhance the above-mentioned youth-based issues and cater to community- based needs.

The purpose(s) for which RESTORATION COMMUNITY YOUTH DEVELOPMENT CENTER, INC. is exclusively religious, charitable, scientific, literary, and educational within the meaning of section 501(c) (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal Income Tax under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provisions of any future United States Law.

Upon the dissolution of the corporation, exempt purposes within the meaning of section 501(c)(3) Of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

ARTICLE IV - Manner of election of directors

The manner in which the directors are elected or appointed shall be stated in the bylaws.

ARTICLE 5 - Limitations of corporate powers

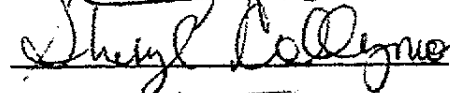

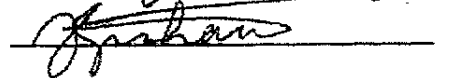

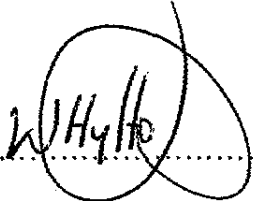
