**ARTICLES OF INCORPORATION  
OF

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation.

**ARTICLE I NAME**

The name of the corporation shall be: Townsend Gift Books Inc.

**ARTICLE II PRINCIPAL OFFICE**

The principal place of business and mailing address of this corporation shall be: 15944 SW 99th Street , Miami, Florida 33196

**ARTICLE III PURPOSES**

The specific purpose for which the corporation is organized is: Inspiring, mentoring, and educating children through the vehicle of instructing them in traditional hand crafts.
