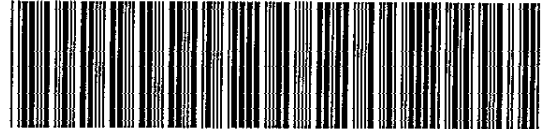

**ARTICLE ONE**

The name and address of this principal corporation is Bola Educational Center, Inc, 7929 N.E. 1<sup>st</sup> Avenue, Miami, Florida 33138, in Dade County. The corporation is organized pursuant to the Florida Nonprofit Corporation Code.

**ARTICLE TWO**


This corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. The corporation is organized under the Nonprofit Public Benefit Corporation Law for, charitable and educational purposes. The programs will consist of but shall not be limited to: Head Start Program and Child Care Program that promotes school readiness by enhancing the social and cognitive development of children through the provision of comprehensive health, educational, nutritional, social and other services. Also Bola Educational Center, Inc. will operate as an After-School Program open to youths of all races, religious and ethnic background. The program will focus on academic studies, peer counseling, mentoring, and preparation for upcoming tests.

The duration of this corporation shall be perpetual no stock and shall have no members.

## ARTICLE FIVE


- a. This corporation is organized and operated exclusively for Educational and Charitable purposes within the meaning of Section 501(c)3 of the Internal Revenue Code.

The Directors are elected in accordance with the Bylaws. The name and address of the persons appointed to act as the initial Directors of this corporation are:





## ARTICLE SEVEN

Any such asset not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is located, exclusive for such purposes or to such organization or organizations, as said Court shall determine which are organized and operated exclusively for such purposes.




