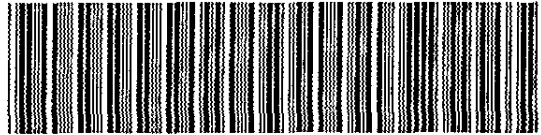

**CERTIFICATE OF INCORPORATION**

SECRETARY OF STATE  
TALLAHASSEE, FLORIDA

**FOR**

**INTERNATIONAL HOUSE OF PRAYER**

**EVANGELISTIC MINISTRIES, INC.**

We, the undersigned, all being persons of full age, of whom at least two-thirds are citizens of the United States, and at least one a resident of the State of Florida, for the purpose of incorporation of an unincorporated christian church, pursuant to Article 210 of the Religious Corporation Law, hereby certify as follows:

1. The principal place of worship of said church and the name and address of its Registered Agent shall be as follows:
  - (a) 6035 Ft. Caroline Road, Jacksonville, Florida 32277
  - (b) Registered Agent: Angela L. Taylor 877 Gavagan Rd. Atlantic Beach, Florida 32223
2. The purposes for which said corporation is to be formed are as follows:
  - a. To organize missionary work for the teaching of the Gospel of God, within, without, and throughout the United States of America.
  - b. To promote the teaching of the Gospel of God among the members of the church and also non-members.
  - c. To ordain Christian workers to visit hospitals, jails and other insitutions.
  - d. To hire or procure the services of competent ministries or persons with or without compensation to promulgate the teaching of the Gospel of God.
  - e. To ordain ministers and reverends to promulgate the teaching of the Gospel of God, to perform marriages, administer Sacraments and the burial of the dead, and to exercise such authority over its membership through suitable regulations and by-laws as may be appropriate for the establishment and maintenance of the christian faith and for such religious purposes as will qualify it as an exampt organization under section 501(c)3 of the Internal Revenue Code.

- f. To rent, lease or purchase such building or edifices which might be needed by the congregation, to alter or repair same, and to dispose same when no longer needed or used by the Corporation.
- g. To buy vacant land or building, alter, develop, build or repair same, for the use of the Corporation, and to dispose of same, when no longer needed.
- h. To purpose, accept, acquire, wholly or in part, and to any lawful use of purpose, and for and upon lawful consideration, mortgages and other similar instruments, and any and all rights under and property therein, also likewise and in like manner, bonds, obligations, debentures, notes, certificate of interest, stock and receipts created by any corporation or corporations, domestic or foreign, associations or firms, trustees, syndicates, governmental divisions or agencies, associations or firms, trustees, syndicates, governmental divisions or agencies, and all rights and orders under the same or any of the same. To exercise in respect any and all rights, power and privileges of, under, issuing or growing out of or by reason of the ownership of authority over or interest in, and as to matter or things to consent or otherwise act there under, or in respect thereto or thereof, to do and perform any and all acts and things for the preservation, protection, improvement and enhancement in value thereof or tending to accomplish such purpose.
- i. To hold and operate such property which shall come into possession of said Corporation; and sell, assign, transfer, or otherwise dispose of any and all of the securities properties and rights which may at any time be acquired or held by this Corporation, and in all respects to deal in and with the same insofar as may lawfully be done under the provisions of the Religious Corporation Law.
- j. To borrow money and to contract debts when necessary for the exercise of its corporate rights, privileges, or for any other lawful purpose of its incorporation; and to mortgage its property, and or to make such deed of trust as may be necessary to secure the payment of such obligation or of any debts contracted for such purpose.
- k. To enter into, make, perform and carry out contracts with any person, firm, corporation, private, public, municipal or political body, under the Government of the United States of America, and foreign countries, as far and to extent that the same may be done and performed under the provisions of the Religious Corporation Law of the State of Florida.

- l. To apply for any and all exemptions from the municipal, state and federal authorities.
  - m. To start a church and have other ministries under this organization.
  - n. To start a parochial school.
  - o. To start or and own a daycare center.
3. The foregoing clauses shall be construed both as objects and powers, and it is hereby expressly provided that the foregoing enumeration of specific power not be construed or held to limit or restrict in any manner the powers of the within Corporation.
4. The title of all real and personal property shall be vested in the trustees and their successors in office.
5. The duration of the Corporation shall be perpetual.
6. A meeting of the church was duly called and held in conformity with the aforesaid article 10 of the Religious Corporation Law at 6035 Fort Caroline Road, Jacksonville, Florida, 32277, at which said meeting, a majority of the qualified voters of the said church, being at least six in number were present.
7. At the said meeting DELORES SNEED WOOLDRIDGE one of the subscriber hereby was Presiding Officer, ANGELA L. TAYLOR, AND DEDRA GOMEZ the other subscribers, were present and voted thereat.
8. The number of trustees thereof shall be three (3).
9. The names of the persons elected as trustees, and terms of office for which they are respectively elected, are as follows: DELORES SNEED WOOLDRIDGE to hold office until the first annual election of trustees, thereafter, ANGELA L. TAYLOR until the second annual election, thereafter DEDRA GOMEZ the third election thereafter.
10. That all the subscribers of the within Certificate are of full age, all citizens of the United States and residents of the State of Florida.
11. That on the first Saturday of November, each year, shall be the general meeting of the congregation for the purpose of electing trustees and officers, and for such other and further business which may be taken up at said meeting.
12. Upon dissolution, the assets will be distributed in accordance with section 501c (3) of the Internal Revenue Code of the United States.

13. That no other application has been made for the above Certificate of Certificate of Religious Corporation.
