RE: Amendment to Articles of Incorporation, Non-Profit Company

Pursuant to the provisions of section 617.1006, Florida Statutes, the undersigned Florida nonprofit corporation adopts the following articles of amendment to its articles of incorporation.

FIRST: Amendment(s) adopted:

Amendment # 1

Vocational Learning Centers, Inc. is organized for educational purposes, in that the organization provides employability skills training and to help the low income and disadvantaged "hard to serve" populations become employed and productive members of society. Vocational Learning Centers, Inc. has a strong policy against racial discrimination or any other type of discrimination based on race, creed, color, religion, or age.

Amendment #2

No part of the net earnings of the organization shall inure to the benefit of, or be distributed to its members, trustees, officers or other private persons. No part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future tax code, or (b) by an organization to which contributions are deductible under section 170(c)(2) of the Internal Revenue Code.

Amendment #3


Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Tax Code. Any such assets not disposed of shall be disposed of by the court of Common Pleas of the county in which the principal office of the organization is located, as said Court shall determine which are organized and operated exclusively for such purpose.
