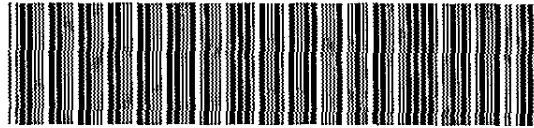



**ARTICLES OF INCORPORATION
OF

Articles of Incorporation of the undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Laws of Florida, do hereby certify:

Article 1: The name of the corporation shall be:

HOME BOUND HELPERS, INC.

Article 2: The Place in this state where the principal office of the Corporation is to be initially located is the City of Eustis, Lake County. The mailing address is the same 36329 Clear Lake Drive Eustis, FL 32736

Article 3: Said corporation is organized exclusively for charitable, educational and humanitarian purposes, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future tax code. The specific purpose of the corporation is to assist, support, and educate the disabled and handicapped; and assist the elderly at home so they won't have to live in a nursing home.

Article 4: The Corporation shall have a minimum of 3 and a maximum of 7 directors. The directors must be at least 18 years of age. Directors do not need to be Florida residents. At this inception, there are 4 directors whose names are as follows:

Article 5: No part of the net earnings of the corporation shall inure to the benefit of or be distributable to its trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purpose set forth in Article 3 hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, this

corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of the corporation.

Article 6: Upon the **dissolution** of the corporation, **assets** shall be **distributed** for one of more **exempt purposes** within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed shall be disposed of by a Court of Competent Jurisdiction of the county in which the principle office of the corporation is then located, exclusively for such purposes or to such organizations, as said Court shall determine, which are operated exclusively for such purposes.




