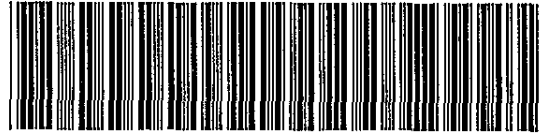



**ARTICLE I: NAME**

The name of this corporation shall be Sabal Palm High School, Inc. (hereinafter, "the Corporation").

**ARTICLE II: PRINCIPAL OFFICE**


**ARTICLE VI: INITIAL REGISTERED AGENT**






