## PLAN OF DISTRIBUTION OF ASSETS PURSUANT TO §617.1406, FLORIDA STATUTES

That other assets, if any, be distributed in accordance with the provisions of the articles of incorporation or the bylaws to the extent that the articles of incorporation or the bylaws determine the distributive rights of members or any class or classes of members, or provide for distribution to others; and
- e.) That any remaining assets be distributed to such persons, trusts, societies, organizations, or domestic or foreign corporations, whether for profit or not for profit; namely to the Social Committee for Sunset Village, Inc.
