Pursuant to the provision of section 617, 1006, Florida Statutes, The Florida Non Profit Corporation adopts the following articles of amendment to its articles of incorporation:

FIRST: Amendment(s) adopted:

**ARTICLE I
Name Of The Corporation**

The name of the Corporation shall be: CHRISTIAN PATRIOTS & COMPASSIONATE REPUBLICANS UNITED FOR A BETTER COUNTRY, INC.

**ARTICLE III
Purposes**

The purposes for which the CHRISTIAN PATRIOTS & COMPASSIONATE REPUBLICANS UNITED FOR A BETTER COUNTRY, INC. is organized are exclusively for charitable, religious, scientific, literacy and educational, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

**ARTICLE IV
Manner of Election of Directors**

The manner in which the directors are elected or appointed shall be in accordance with the methods provided in the corporation By-Laws.

**ARTICLE IX
Limitation of Corporate Powers**

No part of the net earning of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be

authorized and empowered to pay any reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercises any powers that are not in furtherance of the purposes of this corporation.

ARTICLE X

Assets Distribution in Case of Dissolution of This Corporation

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

SECOND: The date of each amendment adoption was: February 16, 2003


THIRD: Adoption of Amendments:
