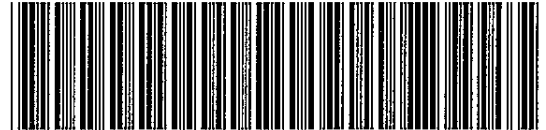

WHEREAS, It has come to the attention of the Directors and Officers of GREGGS TEMPLE AME CHURCH, INC.

1. The African Methodist Episcopal Church, Book of Discipline has not been designated therein as the bylaws governing the corporation and in order to cure this inadvertence the Articles of Incorporation are hereby amended to include the additional paragraphs which shall be known as Article 8. This paragraph is to be designated as the Bylaws of this corporation by reference.
2. That the Pastor appointed annually by the presiding Bishop of the 11 Episcopal District of the African Methodist Episcopal Church, shall serve as President of the GREGGS TEMPLE AME CHURCH, INC.

NOW THEREFORE, be it resolved that paragraphs are to be added to and become part of the GREGGS TEMPLE AME CHURCH, INC. Articles of Incorporation, which shall read as follows:

Article VIII. Bylaws.



Article IX. Executive Officer.


Be it further resolved that a paragraph is added to and become a part of the GREGGS TEMPLE AME CHURCH, INC. Articles of Incorporation
