ARTICLES OF INCORPORATION

FOR

ASOCIACION PRO-INTEGRACION HISPANOAMERICANA, INC.

The undersigned, acting as incorporator (s) of a corporation pursuant to chapter 617, 501^o Florida Statutes, adopt (s) the following Articles of Incorporation:

ARTICLE I NAME:

The name of the corporation shall be:

ARTICLE II, PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS

ARTICLE III PURPOSE (S)

The specific purpose(s) for which the corporation is organized is (are):

- a) To operate as a corporation not-for-profit pursuant chapter 617, Florida Statutes.
- b) Encourage the spirit of integration and cooperation of the Hispanic people.
- c) To stimulate people to be U.S. Citizens.
- d) Encouraging people to vote and participate in common activities to improve our society and goals.
- e) To create an organization to raise contributions and spend funds to achieve these purposes.

- f) To operate on a non-partisan basis.
- g) To have and exercise all rights and powers conferred on not-for-profit corporations under the laws of the state of Florida, or which may hereafter be conferred on not-for-profit corporations.
- h) Notwithstanding any of the above statements of purposes or powers, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the primary purpose of this corporation.

ARTICLE IV – MANNER OF ELECTIONS OF DIRECTORS:

The manner in which the directors are elected or appointed is as follows: The business and affairs of the Corporation shall initially consist of three (3) directors, but which number may be increased from time to time by the Bylaws of the Corporation but which shall never be less than three (3). The Bylaws shall provide for the method of selecting and the method of determining the number of directors.
