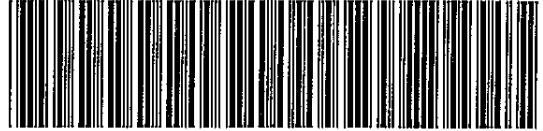

ARTICLES OF INCORPORATION

SECRETARY OF STATE

The undersigned, incorporator, for the purpose of forming a corporation in compliance with Chapter 617 of the Florida Statutes, (Not for Profit) hereby adopts the following Articles of Incorporation:

ARTICLE 1: NAME

The name of the corporation shall be CHRIST APOSTOLIC CHURCH (VINEYARD OF BLESSING), INC. hereinafter referred to as the "Corporation".

ARTICLE 11: PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be 7773 FAIRWAY BLVD., MIRAMAR, Florida 33023.

ARTICLE 111: PURPOSE

The purpose for which the corporation is organized is for religious activities and gatherings in the Tri- County.

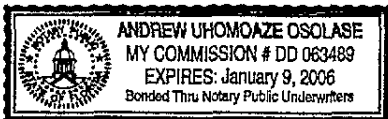
