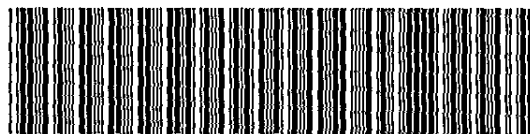


Please find enclosed Articles of Incorporation and Bylaws for a new, non-profit corporation plus the necessary fees.

ARTICLES OF INCORPORATION FOR

La Iglesia de Ciencia Religiosa de Pinellas, el Centro de Vida Abundante, Inc.

The undersigned acting as incorporators of a non-profit corporation pursuant to chapter 617 of the Florida States adopt(s) the following articles of incorporation:

Article I: Name

The name of the corporation shall be La Iglesia de Ciencia Religiosa de Pinellas, el Centro de Vida Abundante, Inc.

Article II: Principle Place of Business and Mailing Address

The principle place of business and the mailing address of this corporation shall be:
4604 49th Street North #74
St. Petersburg, FL 33709

Article III: Purpose(s)

Said corporation is organized exclusively for charitable, religious, educational, literary and scientific purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Notwithstanding any other provision of these articles, this corporation will not carry on any other activities not permitted to be carried on by an organization exempt from federal income taxes under the aforementioned internal revenue code or future federal tax codes.

In the event of dissolution, the residual assets of this organization will be turned over to one or more organizations which themselves are exempt under the internal revenue code.

Article IV: Trustees

The manner in which the trustees are to be elected or appointed is as stated in the by-laws and shall consist of a minimum of three members to a maximum of nine members who need not be residents of Florida.

Article V: Indemnification

Each present or future officer, trustee, or employee, whether or not then employed or in office, shall be indemnified by the corporation against expenses actually and necessarily incurred by or imposed upon such officer, trustee, or employee (including but not limited to judgments, costs and counsel fees) in connection with the defense of any action, suit or proceeding in which such officer, trustee or employee is made a party by reason of being or having been a trustee, officer or employee of this corporation, except in relation to matters as to which such officer, trustee or employee shall be adjudged in such action, suit or proceeding to be liable by negligence or gross misconduct in the performance of duty. Such indemnification shall not be deemed exclusive of any other rights to which such officer, trustee or employee may be entitled under any by-laws, agreement, vote of the organization members or as a matter of law or otherwise.
