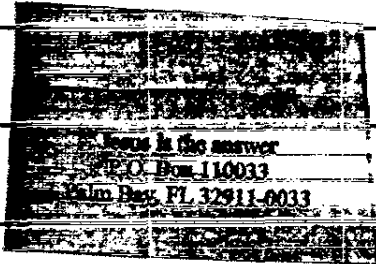

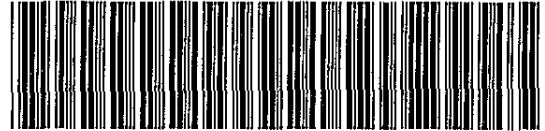

We, the undersigned, do hereby associate ourselves together for the purpose of becoming Incorporated under the Laws of The State of Florida applicable to corporations not for profit, and do hereby certify that

ARTICLE I

The name of the corporation shall be Jesus Is The Answer For The World Revivals, Inc.

ARTTICLE II

The principal place of business and mailing address of the corporation is located at 1658 Glendale Ave. N.W., Palm Bay, 32907

ARTICLE III

The general objects and purposes for which this corporation is organized is to preach and teach the Gospel of Jesus Christ as set forth in the Old and New Testament Scriptures; to practice and promote the Christian Religion according to the Gospel of the New Testament Scriptures; to convert persons to the Christian Religion; to build for religious worship and instruction, churches, schools of Bible training or theology, pastoriums, or other charitable and benevolent institutions connected therewith of a religious and educational character, to receive grants, offerings, gifts and any other charitable donations for the furtherance of the aforesaid objects and purposes.

Said corporation is organized exclusively for religious purposes within the meaning of Section 501©(3) of the Internal Revenue Code of 1954(or the corresponding provision of any future United States Internal Revenue Law) Notwithstanding any other provisions of these articles, the corporation shall not carry any other activities not permitted to be carried on by an organization exempt from Federal Income tax Section 501©(3) of the Internal Revenue Code.

In general, doing anything necessary, proper, advisable and convenient for the accomplishment of the above said purposes, and to do the other entire things incidental to them or connected with them that are not forbidden by the Florida Corporation laws or by these Articles of Incorporation.

No part of the net earnings of this corporation shall inure to and for the benefit of or be distributed to its adherents, officers, or other private persons, except that the corporation shall be empowered to pay reasonable compensation for services rendered and to make payments and distributions for charitable or religious purposes.

ARTICLE IV

The business affairs of the corporation shall be managed by the President (who shall be the Evangelist), the Secretary, the Treasurer, and the corporate board of the corporation. The office of the President shall be filed by the Evangelist of Jesus is the Answer, Inc. The Evangelist and the Board of Directors shall appoint the office of Secretary and Treasure by an annual election after the first year. The office of the Secretary and treasurer may be filled by the same person. The manner of election and /or appointment of other officers in filling vacancies, occurring between the annual meetings of the corporation, by death, resignation or otherwise shall be prescribed by the by-laws of this corporation and/or by the President's supervision. Each officer of the corporation must be and stay in good standing of said ministry.

ARTICLE V

Said officers shall consist of an Evangelist/ Director, Secretary, Treasurer, and Trustees comprising the corporate board of the corporation. The Evangelist who is director of this affiliated ministry must be a minister. And said Evangelist or his/her successor must remain in good standing.

ARTICE VI

The initial Registered Agent of the corporation will be Rev. Ann Marie Toraya, 1658 Glendale Ave. N. W., Palm Bay, Fl 32907. I hereby am familiar with an accept the duties and responsibility as Registered agent.

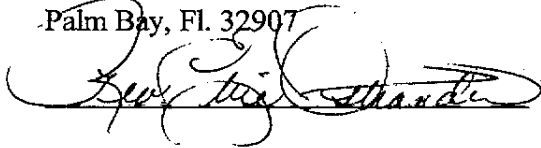

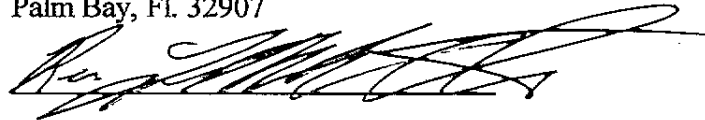

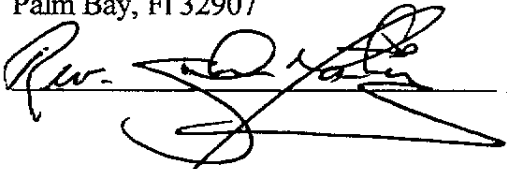
