

ARTICLES OF INCORPORATION

The undersigned, desiring to form a corporation (hereinafter referred to as the "Corporation") pursuant to Chapter 617.0202, F.S., of The Florida Not For Profit Corporation Act (hereinafter referred to as "Act") execute the following Articles of Incorporation.

ARTICLE I – Name

The name of the corporation shall be:

ARTICLE II - Principal office

The principal place of business and mailing address of this corporation shall be:

ARTICLE III - Purpose

The purpose for which the Corporation is organized is:

To restore the vitality and integrity to the enduring fundamental principles of life and living, in order to enhance the quality of life of all peoples.

To build an institution to engage in training and education, advocacy, and dissemination of biblically-centered information and materials to all peoples, relating to life for the purpose of empowering them to passionately pursue and operate in their fullest potential by using their God-given talents and gifts.

Providing biblically-centered charitable assistance and humanitarian work including, but not limited to, the distribution of food and clothing, operating centers for the homeless, substance-abusing and mentally ill persons, orphanages, learning institutions, and training and rehabilitation centers.

To do all other acts necessary or expedient for the administration of the affairs and attainment of the purposes of the Corporation.

This Corporation is organized exclusively for one or more of the purposes as specified in section 501(c)(3) of the Internal Revenue Code, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or Corresponding section of any future federal tax code.

ARTICLE IV – Manner of election.

The manner in which the Directors are elected is by the affirmative vote of the majority. Directors shall be of the age of majority in this state and collectively they shall be known as the Board of Directors. Each Director shall hold office for the term to which he/she is appointed or elected and until his/her successor has been elected or appointed and qualified or until his/her earlier resignation, removal from office, or death.

ARTICLE V – Initial Director/Officers

The initial number of the Directors shall be 3 which number may be increased or decreased (but not fewer than 3) pursuant to the bylaws of the corporation. The names of the directors who shall act until the first meeting or until their successors are duly chosen and qualified are:




