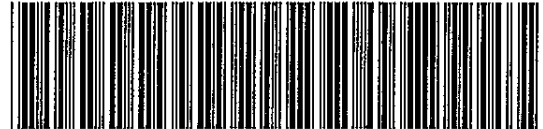

6. Encourage all those who desire and are able, to participate.
7. Provide a service for the betterment of the community.
8. Foster individual and team sportsmanship, self-discipline, self-reliance, teamwork, communications, physical fitness, and trust and confidence through the sport of competitive cheerleading.
9. Promote the development of the athlete as a total person, including but not limited to academics, sportsmanship, and community service and involvement.
10. Provide a fundraising vehicle to assist with funding of those who compete in or on competitive cheerleading.
