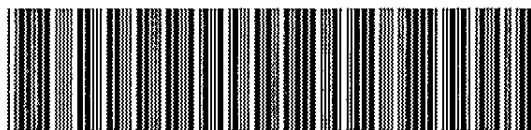

**ARTICLES OF INCORPORATION
OF
NEW ZION PRIMITIVE BAPTIST CHURCH OF SANFORD, INC.
(A Florida Nonprofit Corporation)**

We, the undersigned, desiring to associate for the purpose of forming a corporation not for profit under the provisions of Chapter 617, Florida Statutes, do hereby agree to the following:

ARTICLE I - NAME AND LOCATION

The Name of this corporation is **NEW ZION PRIMITIVE BAPTIST CHURCH OF SANFORD, INC.**, of 2390 Green Way, Sanford, Florida 32771.

ARTICLE II - PURPOSES

The purposes for which the corporation are organized are:

To conduct a church in Seminole County, Florida in accordance with the precepts of the Primitive Baptist Church as adopted from time to time by the National Primitive Baptist Convention and to promote the spirit and teaching of Christianity; to provide a means and manner for its members to find spiritual guidance; to promote a spirit of brotherly love, friendship and benevolence and to promote the spiritual welfare of the congregation and its members.

In addition to the foregoing, the corporation may engage in any activity or business permitted under the laws of the United States and the State of Florida, including the specific power and authority to engage in the following:

(a) To manufacture, purchase, or otherwise acquire; and to own, mortgage, pledge, sell, assign, transfer or otherwise dispose of; and to invest in, trade in, deal in and with, goods, wares, merchandise, real and personal property and services, of every class, kind

and description.

(b) To conduct business in, have on or more offices in, and buy, hold, mortgage, sell, convey, lease or otherwise dispose of real and personal property; including franchises, patents, copyrights, trademarks, and licenses, in the State of Florida and in all other states and countries.

(c) To contract debts and borrow money, issue and sell or pledge bonds, debentures, notes and other evidences of indebtedness; and execute such mortgages, transfers of corporate indebtedness as required.

(d) To purchase the corporate assets of any other corporation and engage in the same or other character of business.

(e) To guarantee, endorse, purchase, hold, sell, transfer, mortgage, pledge, or otherwise acquire or dispose of the shares of the capital stock of, or any bonds, securities, or other evidences of indebtedness created by any other corporation of the State of Florida or any other state or government, and while owner of such stock to exercise all the rights, powers and privileges of ownership, including the right to vote such stock.

ARTICLE III - MEMBERS

Any individual may become a member hereof by following the established procedure for admission to membership of the Primitive Baptist Church as set by the National Primitive Baptist Convention.

ARTICLE IV - DURATION

The period of duration of the corporation shall be perpetual.

ARTICLE V - NONSTOCK CORPORATION

This corporation shall be nonstock, and no dividends or pecuniary profits shall be

declared or paid to the members thereof.

ARTICLE VIII - OFFICERS

The names of the officers who are to serve until the first election of appointment under the Articles of Incorporation are the same as those set forth in Article VII above.

ARTICLE IX - REGISTERED AGENT

The name of the initial Registered Agent of this corporation is **ROBERT WHITTAKER**. The street address of the initial registered office of this corporation is **2390 Green Way, Sanford, FL 32771**.

ARTICLE X - BYLAWS

The bylaws of the corporation are to be made, altered or rescinded by the Board of Directors.

ARTICLE XI - AMENDMENT

Amendments to the Articles of Incorporation may be proposed by the Board of Directors and adopted upon the majority vote of the Board of Directors.

ARTICLE XII

No person, firm or corporation shall ever receive any dividends or profits from the undertaking of this corporation and upon dissolution of this organization, all of its assets remaining after payment of all costs and expenses of such dissolution shall be distributed to organizations which are qualified for exemption under Section 501 (c) (3) of the Internal Revenue Code, or to the Federal Government, or to a state or local government, for a public purpose, none of the assets shall be distributed to any member, officer or trustee of this corporation. Notwithstanding any other provision of these articles, this corporation shall not carry on any other activities not permitted to be carried on by (a) a corporation exempt from federal income tax under Section 501 (c) (3) of the Internal Revenue Code of 1954 or the corresponding provisions of any future United States Internal Revenue laws, or (b) a corporation, contributions to which are the deductible under Section 170 (c) (2) or

the Internal Revenue Code of 1954, or any other corresponding provisions of any future United States Internal Revenue Law, and in addition, notwithstanding any other provisions of these articles, this corporation is formed exclusively for charitable and educational purposes.

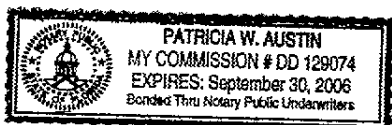
