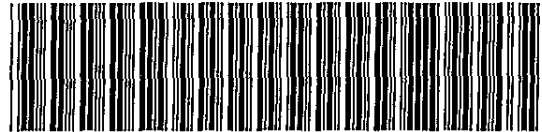

Pursuant of the provision of section 617.1006, Florida Statutes, the directors of the Priscilla Ann Daniels Akins, Inc. adopted the following amendments to the Articles of Incorporation and bylaws this 17<sup>th</sup> day of March 2003:

**Amendment #1**

**Article I**

**Name of Corporation**

The name of this corporation shall be Priscilla Ann Daniels Akins  
Ministries, Inc.

**Amendment 2#**

**Article II**

**Corporate Purpose**

The purpose of this corporation shall be to raise , receive and maintain a funds of real property, personal property or both and to distribute and administer said funds or funds, including any income or interest generated there from, exclusively for charitable, religious and educational purposes.

This purpose shall include, but not limited to:

1. The formation and maintenance of a church,
2. To establish new churches and encourage growth in existing churches by providing support services, financial and otherwise, for churches to accomplish the ministry purpose at home and abroad.
3. To establish community outreach through the formation a fellowship which shall consist of the pooling of other churches and religious organizations that share in the common purpose and belief of the Holy Scriptures with this corporation being the central headquarters.
4. To form a recreational center for teenagers, assistance for the homeless and needy, within the meaning of the Section 501c3

5. To advance the teaching of the gospel of Jesus Christ locally, globally, and internationally through its missionary and evangelist ministries.
6. To establish a school for the religious and educational instruction for the children and adults under the direction of the church and its ministries.
7. This church also performs the following sacerdotal duties in accordance with the Holy Scriptures contained within the bylaws of this organization: Weddings, Funerals, Holy Communion. License and Ordination of Ministers, Spiritual Guidance, Administration of Church Affairs, Regular Worship Services, Teachings of the Holy Scripture, and Baby Dedications.

### **Article VIII** **Advisory Board**

This corporation may elect to have an advisory board consisting of members and nonmembers who possess various expertise in subject matters that will prove beneficial to the accomplishing of this ministries mission and provide structural integrity to this corporation. The advisory board exist solely for advice purposes only. These board members shall have no voting powers or decision making in any church or corporate matters. The advisory board shall be indemnified as in the case of this corporation initial Board of Directors.

### **Article IX** **Accounting Period**

The accounting period for this corporation shall be January 1 to December

31

## Article VIII Bylaws

### **Section 1. Scriptural Conduct of Living Clause**

Any person(s) accepting membership or fellowship into this ministry shall maintain a lifestyle of holiness that is in compliance with the Holy Scriptures as ministered by the leadership of this church. Any person, whose views and lifestyle proves inconsistent with the doctrines and beliefs of this ministry, shall be subject to discipline as deemed by the Pastor/Overseer of this church. Discipline may be in the form of reprimand, termination of position or excommunication from this local assembly. All matters shall be handled in a lawful assembly and resulting actions taken shall be done under the witness of two or more.

### **Section 2. Church Fellowship and Membership Requirements**

Any person shall be eligible for membership in this church with provision that the said persons agree to obey the doctrines and teachings of the Holy Scriptures as set forth in the church by laws. The member agrees to:

1. Tithing and providing financial support in accordance to Malachi 3:10
2. Participation through prayer, fasting and personal involvement of its various missions and ministries
3. Obey the Overseer(s) and leadership of this ministries
4. Shall seek out the lost and unsaved by going forth into the hedges and highway and compelling them to come that they might be saved in the Name of Jesus Christ.
5. Shall not misrepresent this ministry or it's affiliates in any unlawful or unauthorized transactions or solicitations.
6. Share compassion and agape love for all people regardless of race, religion or religious affiliation.
7. Cannot have dual membership (membership of two individual churches)
8. Positive Attitude and work well with others.

### **Section 3. Ministry Participation.**

As adopted by the ruling governments of this church, the following guidelines have been set forth for persons seeking participation on any ministry of this body.

1. Stable membership of 1 year or at Pastor/Overseer Discretion
2. Attend all meetings or give notice of inability to attend
3. Seek out Education or Professional skill to enhance knowledge that

- will be beneficial to the efficiency of this corporation.
4. Agrees only to perform those duties which are authorized by the leadership of this ministry.
  5. Must have accepted the Lord Jesus Christ as Personal Lord and Savior and be filled with the Holy Spirit.
  6. Faithful in all duties and possess performance with the utmost integrity
  7. Possess good moral report among fellow congregant and community

#### **Section 4. Spiritual Guidance**

Spiritual Guidance is available to all members of this church and non-members may request this service with completion of a release of liability statement as provided by this ministry. The guidance or counsel provided is based upon the interpretation of the Holy Scriptures as set forth in the church bylaws. This ministry reserves the right release any information contained within the session to authorities if there has been a crime against another committed or their property, potential of suicide or self-harm. No information will be released in the presence judicial proceedings such as divorce or lawsuits.

#### **Section 5. Marital and Divorce Counseling**

Pre-Marital and Divorce Counseling shall be available in accordance with the State Law upon request and availability of the ministry.

### **Article IX**

#### **License and Ordination of Ministers**

Upon satisfactory evidence of the divine call to the Ministry and whose views upon examination prove consistent with the beliefs and doctrines of this ministry, candidates for licensure and ordination, shall be presented by the pastor/overseer of the church and receive confirmation before the congregation. The minister shall receive a certificate of licensure and ordination that shall be the appropriate ministerial signatures and church seal. Any minister bearing a license from this ministry shall maintain activities and engagements under the approval of the Pastor/Overseer of the church. Should any unauthorized activities, breech in Christian Conduct, termination of membership occur, the leadership reserves the right of revoke and not endorse the minister's license.

Minister's currently holding licensure from another ministry of like faith or from an affiliate, whose scriptural foundation prove consistent with the doctrines and beliefs of this ministry may have his or her license recognized and endorsed by this ministry at the Pastor's/Overseer discretion.

## Article X

### DBA'S and Fictitious Name

Priscilla Ann Daniels Akins Ministries, Inc. reserves the right to operate under the legal fictitious Name *Word of Life Ministries Outreach Inc.* as recorded by the Department of State. *Word of Life Ministries Outreach Inc.* shall operate as the headquarter church for the fellowship ministry. The Fellowship ministry of this corporation shall operate under the fictitious name of *Unity Fellowship & Worship Outreach Inc.* as recorded by the Department of State. This corporation reserves the right to have other fictitious names for its ministries provided by and as it benefits the need of this corporation.

## Article XI

### Fellowship Requirements

**Section 1 Admission.** Any existing ministry that desiring to receive admission into this fellowship with Priscilla Ann Daniel Akins Ministries, Inc. may do so at the discretion of the Board of Directors in the which the Pastor of Word of Life Ministries Inc., Pastor Priscilla A. D. Akins shall be Chief Overseer. Although the churches or ministries seeking admission to this ministry may maintain activities independent in nature, they must agree to maintain activities that;

1. Do not conflict with doctrines and teachings of this ministry
2. Maintain activities and financial accountability within legal parameters of the 501c3 code of the Internal Revenue Code
3. Provide financial support to the central headquarters ministry
4. Participate in activities as established by the headquarters church
5. Share information and helps that will prove to be beneficial and expansion of this ministry.
6. Maintain policies and procedures established by the fellowship
7. Present any grievances in a lawfully assembly in an orderly and discreet manner

**Section 2. Voluntary Withdrawal.** Any Pastor of an existing church that is granted permission into the fellowship may withdraw from the fellowship for any cause by giving a notice of explanation to the overseer of the fellowship. Upon termination of membership, the said church is released from all financial and contractual responsibilities of the fellowship.



**Section 3. Removal Upon Cause.** An existing church may be removed from the fellowship based upon its failure to adhere to the prerequisites for membership set forth in section 1. of this Article. In determining whether or not a church should be removed from the fellowship, A board consisting of the members from the remaining churches of the fellowship shall cast a vote with the final approval of the Chief Overseer.

**Section 4. Settlement of Debts.** Any existing church who is no longer desires to be a part of the fellowship shall ensure that all debts to the fellowship incurred by that church shall be settled in a lawful manner.

## **Article XII**

### **Standing Committees**

Standing committees shall exist to direct, manage, and support and have responsibilities for the ongoing programs and functions of this ministry.

New committees may be formed or deleted at any time as deemed necessary by the leadership of this church. All committee participants must be members of this ministry or its affiliates.
