Pursuant to Section 617.1006 of the General Statutes of Florida, the undersigned nonprofit corporation hereby submits the following Articles of Amendment for the purpose of amending its Articles of Incorporation.

The text of each amendment adopted is as follows:

1. The name of the corporation is **STRENGTH FOR THE JOURNEY, INC.**
2. Additional purposes for which the corporation is organized are
 - (a) To support and encourage communications and extension of the Christian life and witness by sound and comprehensive preaching and teaching of the Holy Bible and of the Gospel of the Lord Jesus Christ to all men, both within fellowship and elsewhere, not only by conventional modes, but also by means which will accomplish such communication developed by modern technology, but not for private profit, to sponsor, participate in, conduct or engage in radio broadcasting, television broadcasting, the printing or reproduction and publication of recordings, books and other materials.
