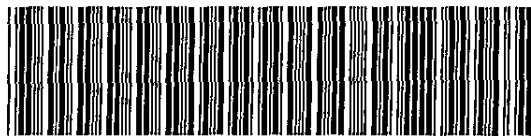

The undersigned subscribers, natural persons competent to contract, for the purposes of the forming a not for profit corporation under the laws of the State of Florida, adopts the following ARTICLES OF INCORPORATION for the corporation:

ARTICLE ONE: NAME - The name of the proposed corporation is: Horeb Ministries, Inc.

ARTICLE TWO: DURATION - The duration of the corporation is perpetual.
