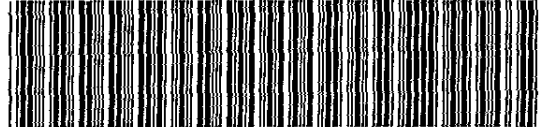

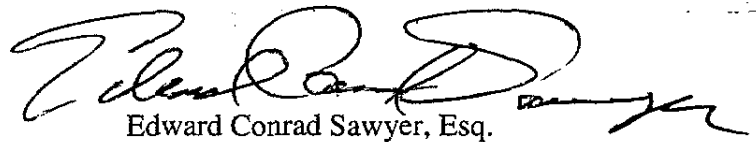

ARTICLE I NAME
