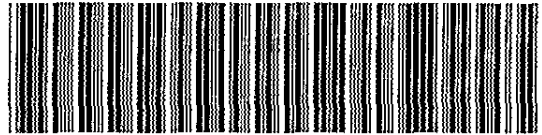

ARTICLE I:

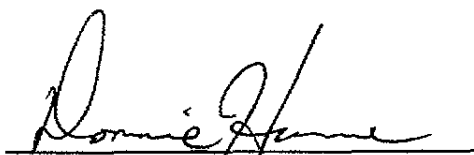

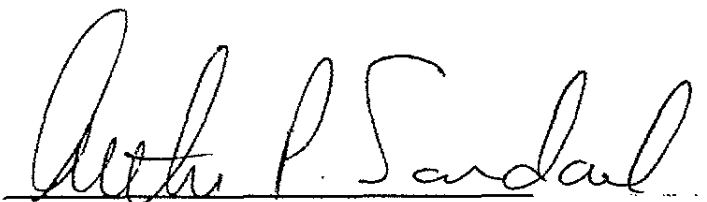
