



ARTICLES OF INCORPORATION OF ST. AUGUSTINE PINES SUBDIVISION HOMEOWNERS ASSOCIATION, INC.

ARTICLE I. TERM OF EXISTENCE

The existence of the Association will commence upon filing of these Articles with the Department of State of the State of Florida and shall continue thereafter in perpetuity.

ARTICLE II. PURPOSE

The association is organized for the purpose of management, maintenance, operation and care of real and personal property, including but without limitation, all ditches, retention or detention areas, drainage, other surfacewater management works, and preservation or conservation areas which are owned or controlled by the association or the owners in common.

- A. To fix and make assessments and collect the assessment by any lawful means;
- B. To borrow money in order to perform the duties and obligations of the Association as set forth herein:
- C. To use and expend the proceeds of assessments and borrowings in a manner consistent with the purposes for which this association is formed;
- D. To maintain, repair, replace, operate, and care for real and personal property, including but without limitation, all ditches, retention or detention areas, drainage, other surfacewater management works, and preservation or conservation areas which are owned or controlled by the association or the owners in common in a manner consistent with the permit issued by the Suwannee River Water Management District and the operation and maintenance plan attached thereto:
 - E. Purchase and maintain insurance:
- F. To make, amend, impose, and enforce by any lawful means reasonable rules and regulations of use of the common areas and association property;

- G. To contract for services with others in order to perform the duties and obligations of the Association as set forth herein;
- I. To do and perform anything required by these articles, the bylaws, or the declaration to be done by the Owner, but if not done by the Owner in a timely manner, at the expense of the Owner;
- H. To do and perform any obligations imposed upon the Association by the declaration or by any permit or authorization from any unit of local, regional, state, or the federal government and to enforce by any legal means the provisions of these articles, the bylaws and the declaration;

The foregoing specific duties and responsibilities are not construed in any way as to limit the powers of the Association. Rather, the Association will have and exercise all the powers conferred upon associations so formed.

ARTICLE III. MEMBERSHIP

Every person or entity who is, from time to time, the record owner of property within the limits of the St. Augustine Pines Subdivision shall be a member of the Association. Membership will be appurtenant to, and may not be separated from the ownership.

ARTICLE IV. DIRECTORS

The affairs of the Association shall be managed by a Board of Directors. The officers shall be elected at the first meeting of the Board of Directors following each annual meeting of the members. There will never be fewer than three directors. The method of election of directors is as stated in the bylaws.

INITIAL CONTROL BY DEVELOPER:

Notwithstanding other provisions contained in these articles to the contrary, Billy Simmons (Owner and Developer), or his successors in interest, will be responsible for the perpetual care, maintenance, and associated liabilities of the stormwater management system until relinquishing that right or ceasing to be the owner of properties within the St. Augustine Pines Subdivision. The developer, prior to relinquishing control of the Association or otherwise allowing control to transfer to the directors of the Association, shall provide at least 30 days written notice to the Suwannee River Water Management District that all terms and conditions placed upon the developer by permits or authorizations from the Suwannee River Water Management District have been satisfied in full and that transfer is proposed to occur on a specific date.

ARTICLE V. ASSESSMENTS

Subject to the rights expressed in the Declaration, assessments for the perpetual care, maintenance, and associated liabilities of the stormwater management system serving the St. Augustine Pines Subdivision shall be established by the Board of Directors of the Association and amended at any annual meeting of the Association, or at any special meeting duly called for such purpose, on the affirmative vote of a majority of the members existing at the time of, and present at, such meeting.

ARTICLE VI. BYLAWS AND AMENDMENT OF ARTICLES

Subject to the rights expressed in the Declaration, the Bylaws of the Association may be made, altered, or rescinded at any annual meeting of the Association, or at any special meeting duly called for such purpose, on the affirmative vote of a majority of the members existing at the time of, and present at, such meeting except that the initial Bylaws of the Association will be made and adopted by the Board of Directors. Amendments to articles or bylaws which directly or indirectly impact operation and maintenance of the surfacewater management system, including but without limitation. ditches, retention or detention areas, drainage, other surfacewater management works. and preservation or conservation areas which are owned by the Association or the owners in common, may be made after approval by the Suwannee River Water Management District. Such approval shall be in the form of a modification to any and all permits issued by the Suwannee River Water Management District under the lawfully adopted rules of the Suwannee River Water Management District in effect at the time of application for such modification. Amendments to the articles or the bylaws which do not impact operation or maintenance of the system may be made without authorization of the Suwannee River Water Management District; however, copies of any such amendments shall be forwarded to the District within 30 days of approval.

ARTICLE VII. REGISTERED AGENT

ARTICLE VIII. DISSOLUTION OF ASSOCIATION

Upon dissolution, the assets of the Association shall be distributed to an appropriate public agency to be used for purposes similar to those for which the Association was created. In the event such distribution is refused acceptance, such assets shall be granted, conveyed, and assigned to any non-profit corporation, association, trust, or other organization established and operated for such similar purposes.

SURFACEWATER MANAGEMENT SYSTEM:


Prior to dissolution of this association, all property, interest in property, whether real, personal, or mixed, which is directly or indirectly related to the surfacewater management system, including but without limitation, all lakes, ditches, canals, retention or detention areas, drainage, other surfacewater management works, and preservation or conservation areas, wetlands, and wetland mitigation areas which are owned by the association or the owners in common, will be dedicated to and accepted for maintenance by the appropriate unit of government or otherwise transferred to and accepted for maintenance by an approved entity. Dedication or approval must be authorized by the Suwannee River Water Management District through modification of any and all permits or authorizations issued by the Suwannee River Water Management District. Such modification shall be made under the lawfully adopted rules of the Suwannee River Water Management District in effect at the time of application for such modification.

ARTICLE IX. DELCARATION OF INTENTION

The specific purposes for which the Association is formed is to provide for the perpetual care, maintenance, and associated liabilities of the stormwater management system serving the St. Augustine Pines Subdivision and its common areas. Generally, the Association's purpose is to promote the health, safety, and welfare of the residents within the Subdivision.
