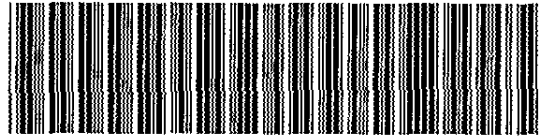

**ARTICLES OF INCORPORATION
OF THE
DARE TO BE DIFFERENT WORSHIP CENTER, INC.**

Article I

The name of this corporation shall be: DARE TO BE DIFFERENT WORSHIP CENTER, INC.

Article II

The address of the principal office of this corporation is 370 Dundee Drive, Poinciana, Florida 34759 in the county of Osceola and the mailing address shall be the same.

Article III

The purposes and powers of the DARE TO BE DIFFERENT WORSHIP CENTER, INC., Corporation, hereinafter termed the "Church" are as follows:

- A. To be a nonprofit corporation as prescribed by section 501©(3) and subsequent amendments, of the Internal Revenue Code, United States Of America.
- B. This organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal Income tax under the section 501©(3) of the Internal Revenue Code of 1954 of the corresponding provision of any future United States Internal Revenue Law.
- C. To conduct religious , missionary, and educational services, activities and projects.
- D. To direct, supervise, oversee, protect, and preserve the fiscal matters and affairs of the Church.
- E. To delegate such activities, operation, and duties respecting the financial and budgetary affairs of the total Church to the Pastor and Deacon Board, subject to the approval of the Bishop.
- F. To hold in trust all real, personal, and mixed property interest and rights of the Church, whether general or local in character, or titled in any department, society, agency, auxiliary or board. The Board of

Incorporators, or board of Deacons shall be amendable to the Quarterly Conference of the Church.

No personal or real property, moveable or immoveable, or mixed, corporeal, or incorporeal, or other thing of value, not held by or under the jurisdiction of an Annual Conference of DARE TO BE DIFFERENT WORSHIP CENTER, INC., shall be sold, donated, mortgaged, conveyed, transferred, abandoned and/or encumbered without the written approval of the Board of Incorporators of DARE TO BE DIFFERENT WORSHIP CENTER, INC.

Notice is hereby given to whom it may concern that the right, power and authority to sell, donate, mortgage, convey, transfer, abandon, or encumber personal or real property, moveable or immoveable, mixed, corporeal, or anything of value held under the jurisdiction of DARE TO BE DIFFERENT WORSHIP CENTER, INC. lies solely and exclusively under the authority and administration of the Pastor/Board of Incorporators of DARE TO BE DIFFERENT WORSHIP CENTER, INC.

- G. The Pastor shall be the Chairman of the Church and the chairperson of all Boards, societies, and auxiliaries in the Church. The Pastor will appoint a Chairperson to act in his/her absence. All business conducted in the absence of the Pastor shall be subject to his/her veto.
- H. The Pastor will nominate the number of deacons needed and submit them to the Quarterly Conference, which shall confirm them or, if it sees fit, reject them. The number of deacons so nominated and confirmed shall serve for a term of one year. The same persons may be nominated annually. The Pastor may serve unlimited terms.
- I. This corporation, by it's Board of Incorporators, shall hold in trust all bequests, gifts, grants, donations and funds that may be given or conveyed directly to DARE TO BE DIFFERENT WORSHIP CENTER, INC. for the benefit of the local congregation, persons, departments, auxiliaries, commissions, and boards of the local church.
- J. It is understood that said Corporation herein shall not be required to accept any property, gift, grant, donation, not in harmony with the purposes and intent of said Church.

Article IV

The manner in which the officers of DARE TO BE DIFFERENT WORSHIP CENTER, INC. are to be elected or appointed is stated in the Bylaws.

Article V

The initial registered office in the State of Florida is to be located at 370 Dundee Drive, Poinciana, Florida 35479. The name of the initial registered agent of the corporation at that address is Jacqueline Alfreda (Dillard) Moore.

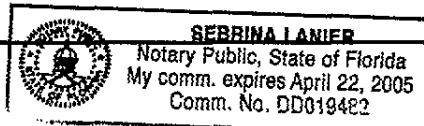
