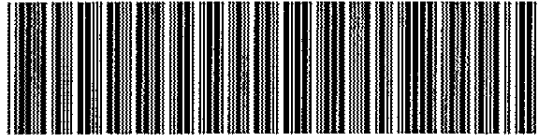

ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of a corporation pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation of such corporation:

ARTICLE I - NAME

The name of the corporation shall be **NORTH LAKE JESUP COMMUNITY, INC.**
This shall be a Florida Not-For-Profit corporation.

ARTICLE II- PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be 2030 Palm Way, Sanford, FL 32773.

ARTICLE III- PURPOSE

The purpose or purposes for which the corporation is organized is to provide effective representation to governing bodies responsible for water-related management, traffic, zoning, and environmental issues affecting our area. To advocate responsible land use in accordance with existing or established regulations and zoning. To provide a forum for residents to present information and ideas, and to express their opinions regarding social and environmental issues. To educate and inform residents about issues affecting the quality of life in our area. To inform residents through all available means of communications, including email, newsletters, flyers, banners, posters, and block captain contact. To promote the general welfare of the community through meetings and social gatherings.

ARTICLE IV- MANNER OF ELECTION

The Directors shall be elected at an annual meeting of the members and shall be approved by majority vote.

The registered agent for this corporation shall be T. Shepard Burr, 2030 Palm Way, Sanford, FL 32773.

ARTICLE VII- INCORPORATOR

ARTICLE VIII

In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in Section 501(c)(3) and 170(c)(2) of the Internal Revenue Code of 1954 or corresponding sections of any prior or future law, or to the Federal, State, or Local Government for exclusive public purpose.
